- To assist, subscribe, co-operative or affiliate, to amalgamate with any other body whether incorporated, registered or not and having altogether or in part objects similar or related in some way to the object of this Trust.
- To borrow or raise loans from individuals/Institutions/Banks on such terms and conditions and on such security as the Board of Trustees may deem it and necessary for the accomplishment of the objects of this Trust.
